

Container Management Systems

Objective

- Approx. 36k tons of PPP packaging shipped into European market per year
- Reducing exposure risk with safe recovery of empty PPP containers

Main Measures

- Proper rinsing by users (incl. video guidance)
- Dedicated collection schemes
- Safe recycling / disposal

- Industry involvement >23
 European CMS schemes
- 18 national industry-run collection schemes recovered 16,300 metric tons of plastic in 2015
- 68% plastic collected was recycled into electric conduit and other safe new plastic products
- Remainder used for energy recovery

Global vision for 2020

"The crop protection industry is taking the lead to ensure safe and responsible management of empty, properly rinsed pesticide containers worldwide.

Through collaboration with governments and country stakeholders, our industry has a goal of recovering 50% of all crop protection containers by the year 2020 worldwide".

dustry's KPIs for Europe From 2020	
European collection rate	> 75%
% CMS coverage	100%
Ecological footprint (recycling rate)	> 75% ^(*)

^{*) 75%} of plastic containers collected; i.e. 56.25% of plastic containers sent into the market





Objective

 To reduce the risk for operators / workers / bystanders / residents and the environment by ensuring the correct use of pesticides

Main Measures

- Training material;
- "Train the Trainers" approach;
- Adequate and certified PPE;
- Communication and awareness campaigns;
- Engineering;
- · Containers management.




Residues Management

Preventing MRL
exceedances –
communicating on food
safety

- Hot-spot focus
- IPM training
- Addressing safety misconceptions

Knowledge transfer from Almeria (ES) – which has seen considerable improvement in MRL compliance for tomato and bell pepper production – into Turkey (where similar conditions can be found)





Anti-counterfeit project

Objective

- Prevent counterfeit & illegal PPPs which is approx. 10% of pesticides in Europe
- Threat to environment and health
- Risk of potential crop damage

Measures

 Awareness raising with farmers, authorities

Roll out of 4-step practical guide

 Presented to customs and pesticide authorities in BG, GR, RO and FI

Introduce a FTIR* for 1st tier analysis at sea ports;

Hamburg pilot (Jan-June 2016)

Operation Silver Axe

- 12 days enforcement action
 (Nov 2015) in 7 MS seized 190
 tons of illegal pesticides
- 2016: Print material, national
 TV and radio campaigns
